Site inductions to be no longer than 30mins

No other works before, or after installation for a period of 12hrs

No curing agents to be used

All concrete slab finishes to be furry, just before burnt (Do Not Broom Finish)

While every effort is made to ensure minimal impact and disturbance to existing infrastructure, and damages incurred along the client advised access route, it the responsibility of the client i.e., concrete curbs, natural grass, landscaping etc.

Soil testing to be provided if required, at an extra expense

Underground service location to be provided if required, at an additional cost

Site Cut and preparation other than already specified

Removal of soil from site, if required will be at an additional cost
